Points of Communication from the Council of Advice

Friday, June 14, 2024
In-person meeting during Heads of Ministry meetings, Bühl, Germany

****Reminder for Council Members and our Liaison partners: Written Liaison Reports are due four times annually: before Council meetings in February, May, July and November.

The June meeting was held during Convocation Heads of Ministry gatherings held from from 13-15 June. Bishop Mark and the Council of Advice, together with leaders of the numerous commissions and committees of the Convocation, met for community building, sharing of information, and confirming the norms and covenants that were drafted together during meetings in February. Consensus at the closing session was extremely positive regarding the progress that has been made towards the foundational goal of these gatherings. That is, as Bishop Mark has written: to create systems that will "make our whole Convocation more joyfully responsive to God's call in mission".

Our meetings were framed in prayer and worship. Additionally, this gathering included a full day of training led by Rev. Daniel Morrow, Rector of the Church of the Ascension, Munich, and Audrey Shankles, Convocation staff person for Communications. They guided us through a crash course introducing ideas and materials they had received during a much lengthier course over a prior two year period. Sessions covered a Life-Cycle Model of Congregational Development, Development of Trust in Congregations, Intercultural Competency and the Cycle of Planned Renegotiation in Congregational Development. The time was intense but filled with tools, and the beginning of useful skills for our continued efforts to live into God's mission for us. The Council of Advice's monthly meeting with Bishop Mark included the following topics and decisions:

- Continuing efforts to contract for further administrative support for the Convocation.
- Progress of exploration to find new software to support the extensive reporting requirements for the Episcopal Relief and Development Refugee grants.
- Progress of ongoing transactions in Paris as we purchase an apartment for the housing of our Bishop with the generous support of the Board of Foreign Parishes.
- A preview of some of the issues of specific interest to our Convocation as we send our deputation to the 81st General Convention in Louisville, Kentucky (June 23-28).
- Status of our proposed budget for 2025. Bishop Mark's proposals have been submitted to the Finance Committee and will be reviewed by Council at a future meeting.

- Unanimous approvals of consent for two new bishops in the Episcopal Church: Julia E. Whitworth as Bishop of Massachusetts and Phil N. LaBelle as Bishop of Olympia
- A report by Bishop Mark on transitions within the Convocation and tentative scheduling of his expected sabbatical in the spring of 2025.
