# **Diocesan Council Topics:**

### **CCS Capital Campaign Update**

The previous evening the COA and those members of the Board of Foreign Parishes (BFP) able to join us for Convention met for the first time. Details were introduced regarding the BFP role in managing the endowment that supports the Convocation as well as initial efforts towards a fundraising campaign. Until now, the BFP has functioned solely as financial guardian over investments that create an endowment solely dedicated to support of our churches in Europe. They have not actively raised funds, but several events this year have catalysed their commitment to solicit an increase to the BFP endowment. The campaign planned with support of the CCS group will focus on new US donations that should not compete with parish stewardship. To help motivate potential donors the BFP requests help with telling the stories of our congregations. Ideas for how to do this are being elicited, Bishop Mark suggested the idea of "Letter from Europe" Zoom gatherings that could generate excitement for our ministries. We are also encouraged to think of alumni from our parishes who are now in the US and might be in a position to contribute.

# **Convention update**

There we were! Thanks to Audrey Shankles, Richard Cole, Richard Easterling with his parishioners and all of the Convention Planning committee for their considerable work organizing the event that was about to begin. 130 people were signed up to WHOVA.

# **Digital Ministry Grants**

Three outstanding grant requests (for All Saints', Waterloo; St. Augustine, Wiesbaden; and Emmanuel, Geneva) were all affirmed by the COA. Audrey Shankles will notify the applicants, and funds will be distributed asap. Audrey will create a committee to assist her review of future grants before sending them to the

COA. The new website will centralize available grant documents. 2025 Digital grants requested before October 15 will be honored by year's end.

### Formal appointment of a gérant of the new SCI

Last month the COA voted to formally appoint our Convocation Treasurer, currently Denis Le Moullac, to this position. The specific text of this action was clarified and unanimously approved. During discussion, Denis gave notice that he plans to retire from his position as Treasurer of the Convocation. Given the complications of our administration and legal status in France, we need to identify someone competent with French law and language for the Treasurer position.

### **Executive Session Council of Advice Items:**

### **Bishop's Report and Matters Arising**

Prior to our meeting, Bishop Mark sent a lengthy memorandum to the BFP, COA, and members of his staff regarding this historic occasion that brought our groups together and thus united the leaders of our church in Europe. In his words:

(the) "Convocation, a relatively small judicatory in the Episcopal Church, has one of the most complex structures to perform the basic functions of a diocese. It is canonically established in the General Canons of the Episcopal Church (Title I, Canon 15); it is legally incorporated as an association mixte under the law of 1907 in France; and the functions of property-holding, endowment management, and charitable fundraising—all things dioceses do—are in the capable hands of the Board."

The Bishop's memorandum elaborated some of the future challenges the Bishop sees for us regarding <u>Episcopal Identity</u>, <u>Effective Evangelism</u>, <u>and Financial Stability</u>. There wasn't time for discussion during the morning COA meeting but some elements were repeated in his addresses later during the Convention and will be topics for upcoming Heads of Ministry meetings as we look to the future and re-evaluate our budget and strategic plans.

Bishop Mark elaborated a few additions to his travel plans and commitments: He will be in the US at the invitation of our new Presiding Bishop Rowe to attend his installation on Nov, 2.

He has been invited to be on the UNHCR (United Nations High Commission for Refugees) Multi-Religous Council of Leaders -
