### Task Force on Stewardship and Financial Justice

Planning and suggestions for appointments of this task force were made during the HOM meeting.

## CCS and BFP Fundraising Campaign Update -

CCS has interviewed a group of potential donors, analysing how likely they would be to donate to an organisation with our profile. CCS has provided an initial report of their results. Unfortunately, the Board of Foreign Parishes is concerned about the very high cost of continuing with CCS and the process is stalled at the moment. Bishop Mark will keep us apprised of his ongoing efforts to move again on fund raising for the Convocation.

## **Bishop's Report and Matters Arising**

Prior to the meeting Bishop Mark sent his written report, requesting total confidentiality. Most details of our discussions are thus not recorded here. Topics as follow:

Council's endorsement of a need for further legal advice as a result of our changed governance of the Convocation

A possible solution to our need for more Convocation Administrative Support.

**General Data Protection Regulation (GDPR) compliance.** With the support of DFMS we have engaged with a law firm to audit the entire Convocation's data management and protection practices, and to advise us on best-practice policies.

Refugee grants reporting.

Bishop Mark has postponed his sabbatical plans.
