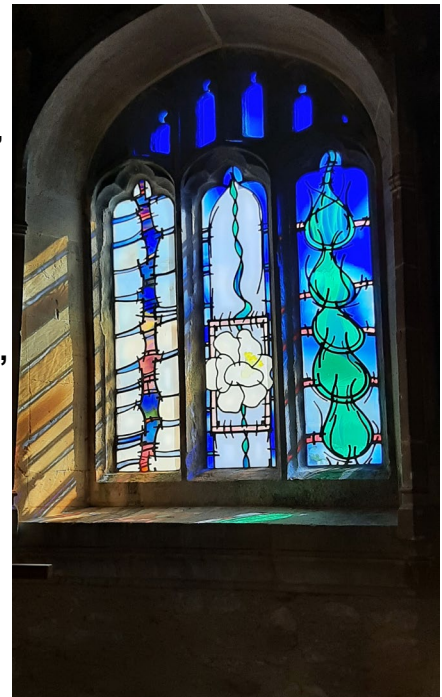
East window of Chapel of St. Mary Tory, Bradford on Avon, UK. Designed by Mark Angus of Bath, installed 1999.

## Convocation website

The Council of Advice and Convocation staff considered the following topics during our May meeting.

## Diocesan Council Topics

**Report from DFMS** (Domestic and Foreign Missionary Society, which is the missionary organisation and corporate body of the Episcopal Church).

Audrey Shankles and Bishop Mark reported briefly on their recent meetings and visit with DFMS. Audrey felt overwhelming support and encouragement from those she spoke with. The reorganization of DFMS following the election of our new Presiding Bishop is completed. There is still much staff uncertainty for those working with Episcopal Migration Ministries since the recent decision of Bishop Rowe to end TEC refugee resettlement grant agreements with the US government. **Report from Finance Committee** – the Committee has not met in the past month. Bishop Mark hopes that the committee can meet during the Augsburg meetings next month. Given the current instability of markets, and the falling value of the \$US, we will need to be very conservative in our funding expectations.

### **Communications and Programming Report**

Audrey continues to update our new website. Data reviewing searches on our new site imply considerable interest in positions available in our various congregations. Perhaps volunteer needs can be highlighted.

DFMS provided computers for Audrey in her new role as Canon for Communications and Programming and will be providing another for Guilia Bonoldi, Chief Welcoming Officer of the CRGP (Convocation Refugee Grant Program).

Audrey is willing to set up a training session or workshop for parish communications officers.

Bishop Mark emphasised the need to restore the library of documents previously available. This is in progress as the old site is carefully reviewed. Efficiently “scrubbing” of the website has proven to be difficult.

Regarding the use of the Planning Center for event registration, credit card fees added by the Stripe software were discussed. Defining who should cover these fees will be clarified after some further consultations.

### **Standing Committee Matters**

#### **Oral Liaison matters as needed:**

Clarification of COMC and Liaison matters - Missions will no longer have COA liaisons to avoid conflicting (or too many) messages with both COA and COMC liaisons. The chair of COMC, currently Audrey Jolivet-Habiby, will report to Council directly regarding Convocation Missions. She will be invited monthly to COA meetings, and hopefully can attend at least quarterly during meetings when written Liaison Reports are requested. A few aspects of our concerns about data and storage of parish archives were briefly noted. These topics will hopefully be raised during the upcoming meeting in Augsburg.

**Consent to the Election of The Rev. Robert Price, Diocese of Dallas** agreed unanimously.

**Resolutions for Convention 2025, Rules for electing Council Officers** Walter Baer prepared text for three resolutions to be put forward at Convention. These request changes in our Constitution or Canons regarding the election of members of Council of Advice as well as the Council's leadership structure going forward. The three resolutions were supported by this Council and will be presented in October.

**Consent to the Ordination of Andrew Kluetz-** Bishop Mark forwarded all of the supporting documentation required for this consent to Andrew's ordination, now planned for September. All members present voted their support.

**Nürnberg Mission Visitation Report** – Vote to release further funds.

Upon review of the report from the COMC, a vote approved the request for an additional 2,000€. It was suggested that they request an additional 1,000€ digital grant for website development. A letter from the President and Bishop will be sent.

### **Council of Advice Matters**

**Bishop's Report and Matters Arising:** Bishop Mark sent his written report prior to the meeting. Topics included:

**--Details of our Bishop's Calendar.** In addition to scheduled meetings and commitments in their roles leading the Convocation, the additional visitations of Bishop Mariann Budde and TEC Presiding Bishop, The Most Reverend Sean Rowe, added kilometres to their busy agendas. Then, there was the invitation to join Bishop Rowe and members of the Anglican Center in Rome to attend the recent inauguration of Pope Leo. Further visitations of Presiding Bishop Rowe are scheduled from June 7-16. These include his participation in the liturgy marking the agreement of full communion between ourselves and the Evangelisch-Lutherische Kirche in Bayern (ELKB), some time in Geneva, and a visit to Paris at Trinity Sunday. The Council is grateful for these many ways that our leaders are making the Convocation and our missions more visible but did clarify that Bishop Mark plans to take some vacation time in August.

**--Progress regarding the transitions** in Rome, Waterloo, Clermont-Ferrand and Paris. We were excited to learn that Rome has come to the end of their search. The Reverend Jonathan Evans, currently rector of Saint Monica's Church in Naples, Florida, has been appointed as priest-in-charge at St. Paul's Within the Walls.

Processes are moving forward in the other three locations.

**--Refugee Grant Program:** Guilia Bonoldi and Bishop Mark met with Episcopal Relief and Development in New York including a virtual presentation to a large number of ER+D staff prepared and presented by Guilia. A new Memorandum of Understanding is underway. Levels of funding being discussed show a significant vote of confidence in the work of all the people directing these projects under Guilia's inspiring leadership.

**--Personnel contracts and other Confidential topics:** Given the complications of leading an organisation with significant financial support from the US across numerous differing nations in Europe, there are always a few places where we need to seek legal advice. This has become the usual in past months as we strive to keep within the legal requirements of the different places we serve at the same time as upholding the Canons of the Episcopal Church and our Convocation.

**Dates of Next Meetings:** June: during HOM meetings 4-7 June; July 7, 14hr.

Our meeting concluded with members praying the Grace together.
